Also bear in mind that some locations may not cater to vegan and gluten-free diets. Should you choose to disregard this clause and you are deemed physically unfit to take part, you will forfeit the tour, there will be no refund given, you shall not take further part, and no assistance will be provided to return you to your point of origin.

What is included in the tour price: Accommodations and breakfasts and their applicable taxes; tour vehicle and fuel; admission to listed tour sites; tour guide and driver; return airfare from Glasgow to Stornoway. Accommodations are chosen to provide quality lodging and service at reasonable cost. <u>Payments</u>: A \$500 deposit is **non-refundable under any circumstances**. The outstanding balance is paid thus: 6 months prior to tour start date — \$350 to secure your flight reservation to Stornoway (non-refundable), along with full passport details. Remaining balance, 3 months prior to tour start date.
